SEAtails Annual Membership Fees and Categories

A. **Individual/Family:** (\$25.00). Anyone supporting the SEAtails mission, or two or more people living in one household supporting the SEAtails mission.

B. **Non-Profit Organization:** (No dues, if reciprocal membership honored; if not, \$100.00). Any club or group of individuals, organized to promote, develop, or maintaining trails, or other organization supporting the SEAtails mission. The organization shall notify the Secretary of the individual who is authorized to be its representative.

C. **Public Agency:** (\$200.00). A local, state, tribe, or federal government entity. Any agency member shall notify the secretary in writing of the name of the individual who is authorized to be its representative.

D. **Corporation/Business:** (\$250.00). Any commercial business or corporation. A corporation or business member shall notify the Secretary in writing of the name of an individual who is authorized to be its representative for each year.

E. **Lifetime:** (\$500.00). Any individual who wishes to pay a one-time membership fee and become a member for their lifetime.

F. **Patron:** Anyone or a business donating more than \$2,000 to SEAtails.

G. **Donation:** Anyone may donate or will funds, properties, Permanent Fund Dividends, securities, etc., to SEAtails for a specific board approved project or the Endowment.

H. **Endowment:** A portion of all receipts (where allowed) will be placed into a SEAtails Endowment Fund to sustain the Corporation.
